
These appointments are subject to following terms and conditions:-

1. Their appointments are subject to police verification and original documents as per criteria.
2. Other conditions of service will be governed by the relevant ordinances/rules and orders in force from time to time.
3. These selected candidates will submit their joining report along with following documents (In Original and two sets of attested documents) in the office of Principal & Controller, R.U.H.S. College of Medical Sciences, Jaipur;

(a) An affidavit on 100 Rupees Non-Judicial Stamp Paper with notary attested mentioning "that he/she is not involved in any kind of Criminal Case/Police Case/FIR and no legal inquiry is pending against him/her"	(b) Degrees / Diplomas / Certificates of educational and other technical qualifications, if any.
(c) Two Recent Passport Size Photo	(d) Certificate of age : Xth Mark sheet/Certificate
(e) Registration of MBBS and PG Degree	(f) Medical certificate of fitness (original)
(g) ID proof issued by Govt. Authorities: Passport/PAN Card, Voter ID/Aadhar Card	(h) Proof of residence: Passport/Voter Card/Electricity Bill/ Telephone Bill/ Aadhar Card
(i) Experience Certificate for all teaching appointments held before joining present institute	(j) Relieving order/Resignation from the previous institution, if any

4. They will be required to submit a medical certificate of fitness from the Medical Officer/Medical Jurist, Jaipuria Hospital, Jaipur or Medical Officer/Medical Jurist, S.M.S. Hospital, Jaipur.
5. They will not be allowed without prior permission of the Vice-Chancellor, to:-
 - d) Appear in any public examination.
 - e) Apply for employment elsewhere, and
 - f) Accept any remunerative or non-remunerative job anywhere.
6. If during the period of urgent/temporary appointment their behaviour and conduct towards the members of the staff is not found satisfactory or if they indulge strike and any other activities as are prejudicial to the academic life and atmosphere of the university, their services are liable to be terminated either before the expiry of the period of urgent/temporary appointment.
7. If any declaration given or information furnished by them is proved to be false or if they are found to have wilfully suppressed any material information, they will be liable to removal from service and such other action as the Board of Management may deem necessary.
8. If the appointment is acceptable on the above terms and conditions they may report to the Principal R.U.H.S. College of Medical Sciences, Jaipur within 07 days from the issuing date of this order.
9. The candidate will have to submit notice for minimum one month in advance before resignation. If notice is not provided than stipend for one month will have to be deposited in college.


